



Village of Saukville Farmers' Market

- Located at East Green Bay Ave. and East Dekora St., adjacent to Veterans Park
- **Sundays - June 12 through October 30** (excluding July 3 & Sept. 4)
- Parking/Set-up location on a first come/first serve basis

2022 Season - Vendor Fee: \$50 - SEASONAL FEE - Includes 19 Sundays, June 12 - Oct. 30 (no market July 4 & Sept. 5)

The Following Rules Apply:

- Market hours: 9:00 a.m. to 1:00 p.m. with vendor set up to be completed no later than 8:45 a.m.
- Attendance in NOT mandatory; Vendors may attend as many market days as desired during the season.
- No vendors shall depart prior to 1:00 p.m., primarily to maintain the safety of everyone in attendance, except in emergency situations. Any vendor vacating their space prior to the close of the market will be in violation of the agreement and may forfeit future participation.
- Prohibited activities include price gouging, loud hawking of wares, objectionable behavior, the sale of live animals, rummage sale items or commercial sale items, or crafts that are not of artisan quality.
- **All fresh produce must be in-season - Wisconsin grown produce.**
- All participants must comply with all applicable state/local licensing requirements with regard to consumables.
- Vendors must set up and take down road barricades at the start and end of the market day if necessary.
- Market will be periodically monitored by the Saukville Police Dept. or Police Reserves.

You will be issued a Vendor Permit which must be displayed. **No vendors will be allowed to participate until they have obtained, and are able to display, their vendor permit.**

Please Note:

The Saukville Farmers Market is now approved as a site where WIC and Senior Farmers' Market Nutrition Program (FMNP) checks can be accepted.

Farmer Authorization Required:

Farmers must attend training and sign an agreement before they accept FMNP checks. Non-authorized farmers will not be paid. In addition, it is considered fraudulent if non-authorized farmers give checks to an authorized farmer for payment; both non-authorized and authorized farmer can be penalized.

If you are not already, and would like to become authorized to accept FMNP checks, please call the Ozaukee County Public Health Dept. at 262-284-8170 to arrange a time for a 20 minute training session.
